STATEMENT OF FAITH

As a ministry of Cornerstone Community Church, we abide by this statement of faith and conduct agreement. As such we require any staff at camp to abide by it. If you sign this form, you agree to abide by this statement of faith and conduct agreement.

1. THE WORD OF GOD - We believe that the Bible is the Word of God, fully inspired and without error in the original manuscripts, written under the inspiration of the Holy Spirit, and that it has supreme authority in all matters of faith and conduct. (John 17:17; Rom. 15:4; II Tim 3:16; I Pet. 1:19-21)

2. THE TRINITY - We believe that there is one living and true God, eternally existing in three persons; that these are equal in every divine perfection, and that they execute distinct but harmonious offices in the work of creation, providence and redemption. (Matt. 28:19; John 1:1-4; I John 5:7)

3. GOD THE FATHER - We believe in God, the Father, an infinite personal spirit, perfect in holiness, wisdom, power and love. We believe that He concerns Himself mercifully in the affairs of men, that He hears and answers prayer, that He saves from sin and death all who come to Him through Jesus Christ. (John 3:16, 17; John 4:24; John 17:5)

4. JESUS CHRIST - We believe in Jesus Christ, God's only begotten Son, conceived by the Holy Spirit. We believe in His virgin birth, sinless life, miracles and teachings. We believe in His substitutionary atoning death, bodily resurrection, ascension into heaven, perpetual intercession for His people, and personal visible return to earth. (Isa. 7:14; John 1:14; Phil. 2:5-11; Heb. 1:2,3; I John 1:7)

5. THE HOLY SPIRIT - We believe in the Holy Spirit who came forth from the Father and Son to convict the world of sin, righteousness, and judgment, and to regenerate, sanctify,



and empower all who believe in Jesus Christ. We believe that the Holy Spirit indwells every believer in Christ, and that He is an abiding helper, teacher and guide. (John 14:26; John 16:7-15; Rom. 8:14-17; Eph. 1:13, 14)

6. ANGELS - We believe that angels are a distinct order of created spiritual beings; that they can appear in human form; that good angels minister to human beings and serve God as special messengers; that Satan, a fallen angel, and his evil angels whom he leads, exercise great but limited evil power in the world, and will suffer final defeat at the hands of the Lord Jesus Christ.

7. REGENERATION - We believe that all men are sinners by nature and by choice and are, therefore, under condemnation. We believe that those who repent of their sins and trust in Jesus Christ as Saviour are regenerated by the (John Holy Spirit. 1:12, 13; John 3:3, 16, 17; Acts 20:21; Eph. 2:1-9, Titus 3:5)

8. THE CHURCH - We believe in the universal church, a living spiritual body of which Christ is the head and all regenerated persons are members. We believe in the local church, consisting of a company of believers in Jesus Christ, baptized on a credible profession of faith, and associated for worship, work and fellowship. We believe that God has laid upon the members of the local church the primary task of giving the Gospel of Jesus Christ to a lost world. (Mat. 16:16-18; Acts 2:38-41; Eph. 2:19-22; Eph. 5:25-27)

9. CHRISTIAN CONDUCT - We believe that a Christian should live for the glory of God and the well-being of his fellow men; That his conduct should be blameless before the world; that he should be a faithful steward of his possessions; and that he should seek to realize for himself and others, the full stature of maturity in Christ. (I Cor. 9:6-8; Eph. 4:11-16; Phil. 2:14-16; Col. 3:17-23; I Thes. 5:17,18)

10. THE ORDINANCES - We believe that the Lord Jesus Christ has committed two ordinances to the local church, baptism and the Lord's Supper. We believe that Christian baptism is the immersion of a believer in water into the name of the triune God. We believe that the Lord's Supper was instituted by Christ for commemoration of His death. We believe that these two ordinances should be observed and administered until the return of the Lord Jesus Christ. (Matt. 28:18-20; Acts 2:41, 42; Rom. 6:3-5; I Cor. 11:23-32)

11. RELIGIOUS LIBERTY - We believe that every human being has direct relations with God, and is ultimately responsible to God in all matters of faith; that each church is autonomous and must be free from interference by an ecclesiastical or political authority; that therefore Church and State must be kept separate as having different functions, each fulfilling its duties free from dictation or patronage of the other.

12. CHURCH COOPERATION - We believe that local churches can best promote the cause of Jesus Christ by cooperating with one another in a denominational organization. Such an organization, whether regional or district conference, exists and functions by the will of



the churches. Cooperation in a conference is voluntary and may be terminated at any time. Churches may likewise cooperate with inter-denominational fellowships on a voluntary independent basis.

13. THE LAST THINGS - We believe in the personal, imminent, and visible return of the Lord Jesus Christ to earth and the establishment of His Kingdom. We believe in the resurrection of the body, the final judgment, the eternal felicity (happiness) of the righteous, and the endless suffering of the wicked. John 5:28, 29; Rev. 20:1-15; II Cor. 5:10; Matt. 25:31-46)

STAFF CONDUCT AGREEMENT

Here at Silver Birch Bible Camp, our desire is to minister to children and youth in a safe, friendly and family atmosphere. We want all campers to clearly hear the Gospel, experience the love of Christ, and see His example lived out in us as staff. In order to accomplish this, we must first of all be committed to Christ, submitting ourselves to Him in every area of our lives. We know that we are not, nor will we ever be, perfect people. However, as we serve Christ we submit to Him, allowing Him to lead us and change us into the people He calls us to be.

We believe we can effectively minister by following Christ's example of living in a God honoring way. In order to be "above reproach", we have a standard of living that we, the staff of SBBC, agree to live by. Although these may not be your specific convictions, we can agree to a code of conduct that brings unity and consistency to the staff. Philippians 2:1-11 speaks of following Christ's example.

We ask anyone serving at SBBC, to commit to the rules, guidelines and Staff Conduct Policy of SBBC (**this includes our SBBC Child Protection Policy**). This would apply for the time that you are here within the camp premises, but also should apply to your life at home. Wherever you are, you are a living, walking testimony of Christ to those who are watching your lifestyle.

Three major arenas where our lifestyles are on display are:

- At Camp
- At Home
- Social Media

People are always watching and learning from us, we must always be careful to live in a way that brings GLORY, not shame, to the name of Jesus. By signing this agreement, I am committing myself to living and acting in accordance with the rules, guidelines, and Staff Conduct Policy of SBBC. I am aware that in failing to keep these guidelines I may be asked to step back from active service with Silver Birch Bible Camp and may be asked to leave the premises.
